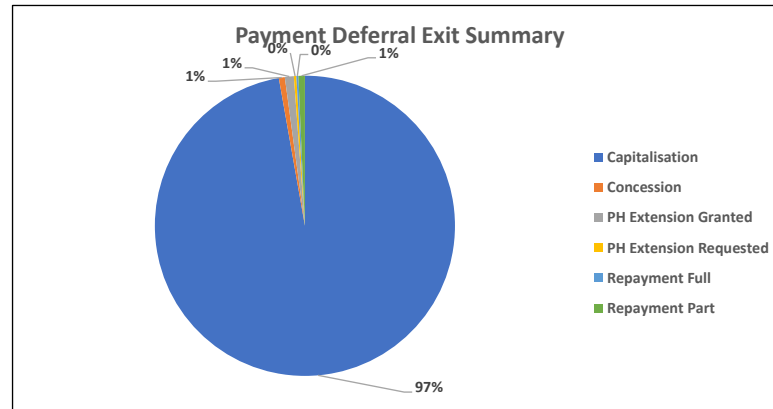
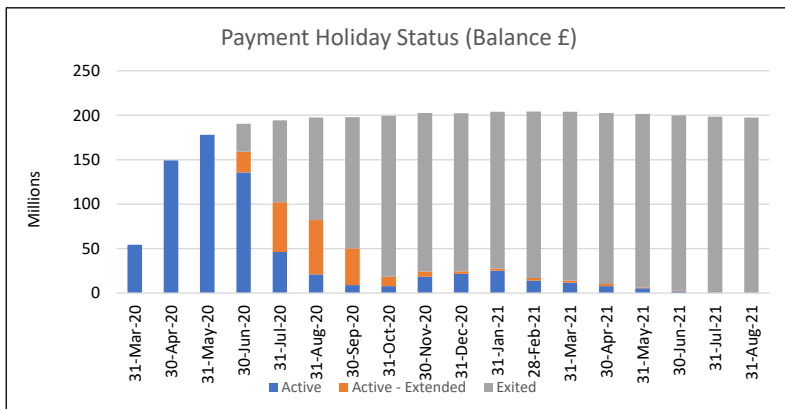
**General Information**
